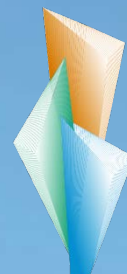

AWARDS BACKGROUND 奖项背景

The BDO ESG Awards recognises outstanding listed companies in Hong Kong that have made a positive impact in the areas of Environmental, Social and Governance (ESG) – those that implement outstanding sustainability initiatives.

BDO, the world's fifth largest accountancy and advisory network, inaugurated the BDO ESG Awards back in 2018, becoming a pioneer in advocating companies' acceptance of their social responsibilities through the integration of sustainable practices into their business models. With 2024 marking the 6th anniversary of the Awards, it has again sought to be both an important motivator of positive change and a symbol of excellence bestowed on companies that have excelled in the areas of ESG.

The BDO ESG Awards has adopted 'Carbon Neutrality' as the theme of this year in recognition of the urgent need to combat climate change. This year's Theme Award will put a spotlight on the industry best practice to recognise listed companies' effort in achieving carbon neutrality and with excellent performance in the following aspects: (1) biggest reduction in carbon emission (absolute and intensity) from business for the year; (2) carbon reduction initiatives launched during the year that could significantly reduce carbon emission from business in the long-run; and (3) long-term vision and action plans implemented.

The Awards that will be presented this year are Best in ESG Awards, Best in Reporting Awards, ESG Report of the Year Awards, Theme Awards and Outstanding ESG Performance of H-share Companies Awards.

全球第五大会计及咨询网络BDO自2018年起举办BDO环境、社会及管治大奖，鼓励企业将可持续发展纳入业务模式，借以承担社会责任，为可持续发展的倡导者。2024年迎来大奖成立六周年，BDO将一如既往推动企业在ESG方面的发展，而大奖亦标志着企业在ESG各个领域表现超卓的象征。

BDO环境、社会及管治大奖本届的主题为「碳中和」，除配合大奖提倡卓越ESG发展的宗旨外，亦带出应对气候变化的迫切需要。今年的「主题大奖」将表扬致力实现碳中和，并在以下三个主要方面表现优秀的上市公司，包括 (1) 年度最大的碳排放减幅（绝对值与强度）；(2) 本年度推出的减排措施能够长远显著减少商业活动的碳排放；(3) 订立的长期愿景及实际计划。

本届大奖所颁发的奖项组别包括「ESG最佳表现大奖」、「最佳ESG报告大奖」、「ESG年度大奖」、「主题大奖」及「ESG突出表现大奖 – H股公司」奖项。

AWARDS CATEGORIES AND JUDGING CRITERIA

Entries from non-H-share companies are placed into two award categories - 'Best in ESG' and 'Best in Reporting'. The top three companies from each of the large market capitalisation, middle market capitalisation and small market capitalisation will be selected as winners of each of the award categories.

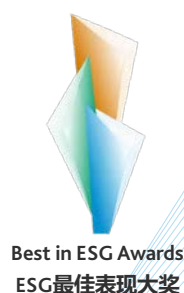
Companies that performed best in 'Best in ESG' and 'Best in Reporting' categories will be awarded the 'ESG Report of the Year'.

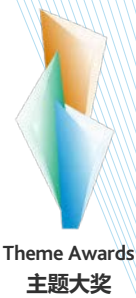

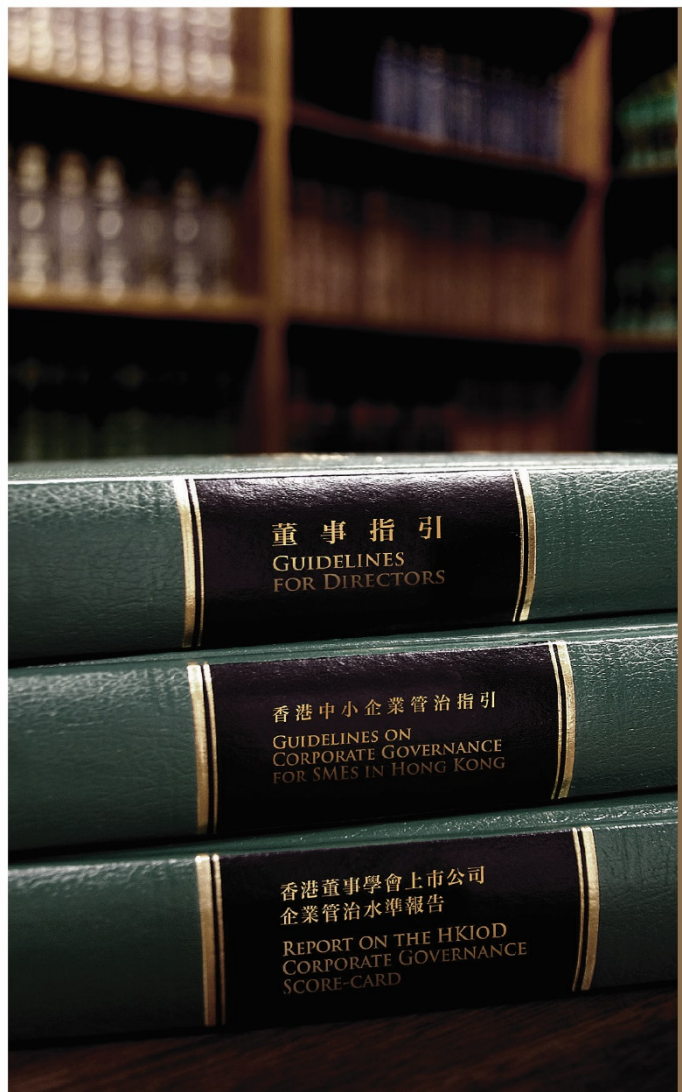

Mr Datwani joined a client as general counsel and senior management of a publicly traded firm. He managed multi-national operations, including governance and cultural challenges. He then made the decision to promote good governance based on his practical experiences, business acumen, and legal knowledge. He is currently the Deputy Chief Executive of The Hong Kong Chartered Governance Institute (HKCGI) to represent Chartered Secretaries and Chartered Governance Professionals in Hong Kong and China.

In addition to his day-to-day managerial duties at HKCGI, Mr Datwani, a thought leader, develops practical advice and conducts research to advance good governance. Additionally, as a member of the global governance profession, he collaborates with CGI, where HKCGI originates, on research projects and makes contributions to global thought leadership initiatives. His oversight included securitisation, covered bonds and REIT corporate rating for Non-Japan Asian issuers. He was the founding CEO, Executive Director and Responsible Officer of Lianhe Ratings Global Limited (the Hong Kong based subsidiary of one of the two largest domestic credit rating agencies in Mainland China) between 2017 and 2023.

Stan has solid and direct green finance and certification experience. Stan is the Chief Representative of Syntao Green Finance International Ltd. with direct experience in external review of sustainable finance framework and green and sustainability-linked financing of Chinese and Hong Kong companies. Stan is the Green Finance Certification Scheme Technical Committee Member of Hong Kong Quality Assurance Agency (HKQAA), where he is one of the approval members of the HKQAA green certification of the bonds issued, and loans borrowed, by Chinese and Hong Kong corporates and financial institutions.

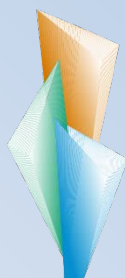
